# Getting Paid Invoicing



#### Service Provider Invoice

- FCC Form 474 aka SPI
- Filed after Form 486 Notification letter received
- Requests reimbursement for discounts on eligible products/services
- Delivered to eligible locations
- For eligible purposes
- Provided by eligible service providers
  - Service Provider Annual Certification (FCC Form 473)



#### Service Provider Invoice

- Corrective SPIN changes
- Electronic submission
  - Invoice Status Report
  - Error files
- Remittance statement
- ACH transfer and FCC Form 498



- Billed Entity Applicant Reimbursement
  - FCC Form 472 aka BEAR
  - Filed after Form 486 Notification letter received
  - E-Cert system
    - Access to online Item 21
    - Access to online BEAR
  - Online BEAR to find certification requests
    - Email from applicant's submission
    - Positive approval
    - Track BEARs for entire history of program (incl. paper)



## Billed Entity Applicant Reimbursement

- Requests reimbursement for discounts on eligible products/services
- Delivered to eligible locations
- For eligible purposes
- Provided by eligible service providers
  - Service Provider Annual Certification (Form 473)
- Applicant has paid the bill in full



- Billed Entity Applicant Reimbursement
  - BEAR Notification Letter
  - Remittance statement
  - ACH email
  - Must pass reimbursement to applicant within 20 business days
  - Dunning

#### Review documentation

- Service Certification match invoice submitted
- Copy of customer bill
  - Volumes of customer bills
  - Comparison with Item 21 attachment
  - Billed party
  - Shipped to party
  - Ineligibles identified
  - Allocations identified



## Collecting Bill Support

Helping Keep Americans Connected

- Review documentation
  - Contract
    - Dates
    - Progress payments
  - Proof of payment by beneficiary
    - Checks
    - ACH

# **Overcoming Rejection**



Helping Keep Americans Connected

- Filling out form completely
- SPIN registered, certified for fund year
- 471 correct, approved by FCDL
- FRN correct, Form 486 Notification Letter
- Discount amount
- Committed amount
- Duplicate submissions



Helping Keep Americans Connected

- Dates
  - Fund Year delivery dates
    - Extensions
  - Contract dates Form 500
  - Billed date
  - Shipped date
  - Invoice deadline new provision for extension
  - Review deadlines timeliness of response



Helping Keep Americans Connected

- Eligible services
  - Item 21 attachment
  - Approved
  - Service substitutions
  - ESL versus Item 21 attachment
    - May be eligible on list but not requested on Item 21 attachment
    - Need service substitution
  - Product replacement



Helping Keep Americans Connected

- Is this correctable?
  - Rejections identified in remittance statement or BEAR Notification Letter
  - Rejections can be corrected in most cases
  - Correct form input and refile
  - Obtain proper documentation and refile
  - Obtain service substitution and refile
  - Obtain proof of payment, delivery, customer bill and refile
  - Appeal to USAC or FCC
