Commitments for Funding Year (FY) 2020 and FY2019

FY2020. USAC released FY2020 Wave 28 Funding Commitment Decision Letters (FCDLs) on November 5. As of November 6, FY2020 commitments total over \$1.86 billion.

FY2019. USAC released FY2019 Wave 77 FCDLs on November 4. As of November 6, FY2019 commitments total over \$2.42 billion.

On the date that FCDLs are issued, you can access your FCDL notification from the **Notifications** section of your landing page in the E-rate Productivity Center (EPC).
